



PUBLIC NOTICE PIVÔ'S ANNUAL AUCTION 2024 - 13TH EDITION

1. PIVÔ ARTE E PESQUISA [Pivô Art and Research] will exhibit the lots to be auctioned on the website (leilaoanualpivo.org.br) at its headquarters, located at Avenida Ipiranga, 200, Loja 54, Centro, São Paulo, SP, between 19th to 26th October 2024;
2. All lots will be auctioned in their current condition, and no claims will be accepted after the Auction;
3. All interested parties must fill out the complete registration form requested by iArremate, and are solely responsible for the data provided and for bids placed;
4. Early bids will be accepted through the website www.iarremate.com until 5:00 p.m. on the day of the Auction, 26th October 2024, starting at 5:00 p.m.;
5. After filling out the registration form on the iArremate platform, bidders will receive a login and password for individual access to the platform. Confirmation of registration may take up to 48 hours;
6. Using his/her individual login, the BIDDER can place bids, early bids, as well as final bids. Bids below the stipulated minimum prices will not be accepted. Early bids will only be accepted up to 5:00 p.m. on 26th October 2024;
7. The WINNING BIDDER will receive an e-mail from the iArremate website, between 2 and 48 hours after the end of the Auction, with the final value of the Auction, as well as instructions for payment (please check spam or other active filters);
8. The WINNING BIDDER expressly authorizes iArremate to share with PIVÔ ARTE E PESQUISA the following data provided in the registration form for the purposes of issuing the fiscal invoice: full name, e-mail, telephone, RG or RNE, CPF, address for delivery of the work and payment details—bidders who do not have an RG (or RNE) and CPF numbers should provide their passport identification number;
9. PIVÔ ARTE E PESQUISA is not responsible for any interruptions, system or connection failures, or other related unforeseen events that prevent or hinder the purchase of any work by any means other than in person, as well as late bids;
10. All other conditions will be governed by Decreto-Lei 21.981 of October 19th, 1932, as amended by Decreto 22.427 of February 1st, 1933, which regulates the profession of the Auctioneer. The jurisdiction of the City of São Paulo is hereby elected for settling eventual disputes related to this Auction.

PAYMENT AND WITHDRAWAL

11. The payment of winning bid(s) must be made under the sole and exclusive responsibility of the BIDDER by 28th October, through identified TED, identified international Wire Transfer/PIX or via Paypal link or Bank slip. No cash payments or unidentified deposits will be accepted;
12. The link for payment via boleto or credit card will be sent in the e-mail confirmation of the winning bid, sent by iArremate. If you have any questions, please contact assessoria@pivo.org.br;

13. The bank details for TED identified are as follows: Banco Itaú (341), Agência: 0170, Conta Corrente: 49247-4. The identifier will be the CPF or CNPJ of the WINNING BIDDER. It is the BIDDER's responsibility to send the proof of transfer in accordance with the stipulated deadlines to the e-mail: assessoria@pivo.org.br;
14. For international payments via Wire Transfer to PIVÔ ARTE E PESQUISA, the WINNING BIDDER should request an invoice via e-mail at assessoria@pivo.org.br confirming the data that must be included in the document; the BIDDER also must send, to the same e-mail address, the proof of transfer in accordance with the deadlines stipulated;
15. If the WINNING BIDDER does not make the payment within the agreed period, he/she will be subject to legal penalties, as well as the issuance of a credit title in favor of PIVÔ ARTE E PESQUISA, in addition to having participation in other Auctions blocked;

DELIVERY

16. After confirmation of payment, PIVÔ ARTE E PESQUISA team will contact you within 5 working days to agree upon and schedule delivery logistics,
17. PIVÔ ARTE E PESQUISA will be responsible for sending the lot(s) bought by the WINNING BIDDER to the address informed in the registration form provided by the platform iArremate, exclusively in the city of São Paulo;
18. Deliveries in the city of São Paulo will be coordinated and scheduled by PIVÔ ARTE E PESQUISA team and will be made in two lots: the first between November 15th and December 15th, 2024 and the second from January 15th to January 30^{ed}, 2025;
19. If it is not possible to receive the delivery on the date scheduled by PIVÔ ARTE E PESQUISA and the BUYER, a second delivery attempt will be made to the same address on a scheduled date. In case the delivery cannot be received again, the BUYER shall have exclusive responsibility for picking-up the work at his own expense from the headquarters of PIVÔ ARTE E PESQUISA;
20. If there is a need to change the delivery address within the city of São Paulo, the BUYER must inform the PIVÔ ARTE E PESQUISA team as soon as possible by e-mail at leilao@pivo.org.br;
21. For WINNING BIDDERS from other locations who cannot pick-up lots on the premises, PIVÔ ARTE E PESQUISA will provide soft packing as a courtesy and can indicate suppliers for transportation and customs clearance. The contracting of services, as well as the costs related to these services, including the need for special packaging, will occur at the expense of and on behalf of the BUYER, exempting PIVÔ ARTE E RESEARCH from any liability for damage or delay during transportation;
22. In cases where delivery is not possible or is under the responsibility of the WINNING BIDDER, it will be the WINNING BIDDER's exclusive responsibility to pick-up the work at PIVÔ ARTE E PESQUISA headquarters by February 29, 2025, during Pivô's working hours;

23. The WINNING BIDDER expressly authorizes iArremate to share with PIVÔ ARTE E PESQUISA the following data provided during registration: full name, email, telephone number, ID, address for delivery of the work and payment details;
24. PIVÔ ARTE E PESQUISA will use the personal data indicated in the item above exclusively for the purpose of issuing tax receipts to the WINNING BBIDDING PARTY and sending information about future editions of the auctions it will hold;
25. The WINNING BIDDER declares to be aware that PIVÔ ARTE E RESQUISA has no responsibility for any use, by iArremate, of the personal data provided in the registration by the BIDDER, this use being subject to the terms and conditions established by iArremate and with which the BIDDER agrees or not.
